Final report: Research grant "On secularism and its discontents" (FWF P-29599)

1. Report on research work

1.1. Information on the development of the project

Overall scientific concepts & goals

The project investigated the so-called "return of religion" in the context of late modernity in general, and its growing discontents, in particular. One most pressing among these discontents concerns the vexed realities of what is called "religious violence." Given the often moralistic and normatively overdetermined staging of this so-called "irrational," horrorist," etc. violence, we have attempted to describe and analyze the proliferating phenomenon of "religious violence" in exactly this perspective.

The threefold structure of our agenda (clearing the context – assessing the crisis of secularism / setting up a conceptual framework / exploring cases of religious violence) has helped us to retain a sharp focus throughout the grant. In a first step, the project broke new grounds in articulating the most malleable trope of "religious violence" in terms of an *original supplement* that appears systemically necessary for upholding our traditional Western economies of violence and related modern social imaginaries. Secondly, we took up the challenge to reshape classical as well as recent accounts in phenomenology of religion in light of the challenges posed by violence and developed a methodological framework for analyzing religious violence on such grounds. In this context, it finally became possible to analyze various instances of "religious violence" (religious zeal, fanaticism, unconditional action) in terms of this "relevant other"—an "other" that is all too often normatively pinned against the untouchable bedrock of discursive reason and the related procedural quest for universal norms.

Changes in research orientation – impact on disciplinary standing & potentials

The originally proposed orientation of our research remained coherent over the whole period of time. Given the thematically differing but methodically intersecting interests of the researchers involved, a variety of different thematic foci had been chosen in regard to the exemplary studies undertaken. The related outcomes, however, perfectly fit into the overall research plans and agenda as outlined in the original proposal. Moreover, the exemplifications we elaborated have added a most relevant *practical* philosophical dimension to the more theoretically orientated arguments that have been developed.

1.2. Most important results and a brief description of their significance

Advancement of the research field & general importance for the development of the field

The project has allowed the team to move their work into the direction of "applied phenomenological research," a domain that has thus far been preoccupied by fields like medicine, esp. psychopathology, anthropology, and the social sciences. As far as the multiple realities of religion in general and "religious violence" in particular are concerned, this practical orientation has proven most fruitful, as our studies on zeal, fanaticism, and the violent potential of "unconditional acts" have revealed. This has proven most important for our disciplinary standing. A heightened interdisciplinary awareness that developed over the course of the grant has effectuated a truly positive influence on both the team's international recognition and the development in this field, more generally regarded. Especially our

research on the so-called "post-secular turn" in phenomenology has raised strong interest across the involved disciplines. As we have shown, the recalibration of phenomenology in this context is of utmost importance for reassessing the capacities of phenomenological research in changing cultural contexts. In this context, our project has bridged a noteworthy gap since it has helped to close the divide between phenomenology and other research directions that target the religious today, esp. post-secular theory (Taylor, Habermas).

Scholarly advances -- Relevance of hypotheses – Development of new research agendas

The threefold structure of this project enabled us to proceed in a most structured way and offered a balanced basis for testing our initial hypotheses. This structured way of advancing not only helped us to find evidence for our basic thesis concerning the role of "religious violence" as an imaginary trope that is co-constituted and sometimes even performatively (re)created by certain practices of "secular violence." Finally, this finding also fed into the development of new fields of research, most notably concerning the perennial question of "political theologies" and their contemporary resurge in an age of waning foundations and contested sovereignties (\rightarrow follow-up grant application).

Relevance of the project for related areas of research – Transdisciplinary issues & methods

As the interdisciplinary exchange of our team has shown, the relevance of (our) phenomenological work for neighboring areas is gaining traction today. Theology, religious studies, critical theory, post-colonial theory and cultural anthropology all share a heightened interest in the disconcerting realities of "religious violence." Encountering difficulties in describing these realities and their interrelations with one's own privileged epistemic position, has recently led to a surging interest in phenomenological descriptions and hermeneutic-phenomenological interpretations that are capable to overcome traditional perceptions of "religious violence." With our elaboration of an integrative phenomenological account for describing and analyzing "religious violence" against the backdrop of secularism and its discontents, we have provided a contribution that appears most relevant to all interested in self-critically confronting the trope of "religious violence" beyond the (all too narrow) binaries of myth and Enlightenment, faith and reason, "the sacred" and "the secular," violence and order.

1.3. Information on the execution of the project, the use of available funds and (where appropriate) any changes to the original project plan

Duration

The total duration of the project was 51 months, including two prolongations (11 + 4 extra / covid-19-related) Within the extra time granted, a series of pending publication projects have been brought on track, and publication projects that had earlier been taken over from the FWF grant I-2785 have meanwhile been concluded, too, or have been taken over by grant I 31919 (PI J. Alvis).

Significant deviations from the original plan

No substantial deviations from the original plan were necessary. Since the original work plan was too optimistic, the series of "case studies" to be dealt with, had been focused a bit more narrowly than originally conceived. This adjustment, however, does not reflect a *substantial* change.

Further leadership experience in the execution of this grant and the parallel work on the bilateral grant I-2785 has helped to strengthen the PI's research output and networking; in 2020 the PI has then started to work as a Senior Lecturer at the department (75% FTE) and has also contributed (25% FTE) to the follow-up FWF grant stand-alone "The revenge of the Holy" (P 31919), which he had originally handed in and which had later been accepted after revisions and is now under the leadership of J Alvis. The PI has also been appointed scientific member of the Research center "Religion and transformation" at the University of Vienna.

■ Jason Alvis, PD Dr. habil.

In 2019, the co-worker has successfully defended his habilitation thesis at the faculty of philosophy and education; he has also been appointed as a scientific member of the above-mentioned research center; he has been invited to several professorial hearings in 19 and 20; in 2019 he has secured the resubmission of a stand-alone grant "The revenge of the holy" for which hen ow is responsible as PI; and thus continues research along lines opened by this grant.

Ruth R. Tietjen. Dr.

The participation of Dr. Tietjen in this grant has provided her with several opportunities to publish her work, conceive new publication and grant application plans for the initial phase of her post-doctoral phase; to integrate her research in a larger network; all this has finally resulted in her being appointed a post-doctoral researcher at the Center for subjectivity research (Copenhagen, Denmark), in a grant led by Thomas Szanto.

3. Effects of the project beyond the scientific field

Effects beyond the scientific field were not explicitly intended. The PI participated in some events outside the sphere of academia, dealing with questions concerning the "return of religion" and the question of "religious violence." All these are minor side effects.
